Introduction and Acceptance of the Terms and Conditions

The general Terms and Conditions of Sale (Conditions) detailed below govern the contractual relationship between the 'User' (hereafter also referred to as 'You' or the 'Customer') and Take Time for Art, LLC. Changes to the Terms of Service and the Website

We reserve the right to update the Website and these Conditions from time to time, at our discretion and without any notice. It is your responsibility to keep up-to-date with the latest Conditions by checking back regularly. Access to the Website

We can't guarantee that the Website will not be periodically inaccessible. We reserve the right to close the Website for short periods of time for general maintenance. We will not be liable if for any reason all or any part of the Website is unavailable at any time, for any length of time.

Availability

We will endeavor to fulfill your order as soon as possible once completed and paid for. If a product should become unavailable after your order has been confirmed and paid for, we will reserve the right to refund the price you paid for the product within 30 days following the date of payment.
